## **UNFINISHED BUSINESS**

A. Sandy River Drive Tree Trimming- concerns brought over safety (fire hazard with dry brush during drought, falling tree limbs/debris in severe weather). A 15 ft overhead canopy height brought up for trimming to allow high profile emergency vehicles. Local residents thought this ws unnecessary and only the dead branches/trees need to be addressed so they do not fall on the roadway. This area directly affects 60 area residents. Suggestion to delay until late fall and lessen fire danger. A resident commented on previous attempt at cutting brush and limbs had detrimental effect on appearance of the River Road scenic drive. An area resident, a couple board members and someone from the highway department will go down Sandy River Dr and gather more information.

## **NEW BUSINESS**

- A. Misty Waters sidewalk proposal area residents presented proposal to build sidewalk at Misty Waters in a couple areas (see attachments). It is to be funded completely through their homeowner's association, and the association will be holding a meeting to vote on the issue coming up August 9<sup>th</sup>. The results will be emailed to Hay Creek township board. It was stated the township will not offer any funding and Misty Waters would need to maintain the sidewalk and talk all liability.
- B. Special Meeting proposal motion made to hold a special meeting to remove a township supervisor and then motion was rescinded. Motion made to accept Supervisor Shelly Hegel's resignation. Motion carried.
